AGREEMENT made between the International Monetary Fund (hereinafter referred to as the "Fund") and John Dec of _____ (hereinafter referred to as "Dec").

- 1. The Fund shall empley Doe as its Managing Director and Doe shall serve as Managing Director of the Fund for the period of five (5) years commencing May 1946. This employment is subject to
 - (a) The right of Dee to resign at any time, his resignation to be effective thirty (30) days after the giving of notice to the Fund;
 - (b) The right of the Executive Directors of the Fund to exercise their power pursuant to Article XII, section h(a) of the Articles of Agreement of the Fund which states "The Managing Director shall cease to held effice when the Executive Directors so decide."
- 2. Dee recognizes that by accepting this employment he pledges himself to discharge his functions and to regulate his conduct in the interest of the Fund. He recognizes that the responsibilities of the Fund are not national but international. Therefore, Dee agrees that in the perfermance of his duties he shall not seek or receive instructions from any government or from any authority external to the Fund. In accordance with the international character of the Fund, Dee further agrees that he will not accept any honor, decoration, favor, gift or fee in respect to services rendered during the period of his employment or service in the Fund and that he will resign his position with the Fund if he should become a candidate for any office of a political character.

3. Dee agrees that he shall not communicate to any person but he have here the shall not communicate to any person other than a Governor, Executive Director, alternate or efficer of here of light of the Fund any unpublished information known to him by reason of his efficial position except in the course of his duties or by reason of the authorization of the Executive Directors of the Fund and that he will exercise the utmost discretion in regard to all matters and information to furnish officially connected such that pertaining to the business of the Fund.

h. Doe agrees that he will not, within a period of two (2) years after termination of this agreement or of any renewal thereof, accept any employment or position with any governmental or public or private organization in which his confidential information might be a source of embarrassment to the Fund.

5. Dee agrees to devete the whole of his time, attention, skill and energy to the business of the Fund. and shall not, directly or indirectly, alone or in association be connected with or concerned or interested in any other business or employment or pursuit whatsoever during the term of his employment (other than the management of his private investments) and that he will resign from any position in public or private employment that he now helds. Doe shall serve the Fund diligently and according to his best ability in all respects and use the utmost endeavors to promote the Fund's interests. Doe shall not serve as a director or efficer of or consultant to any company or organization or held any public office in any country without the prior approval, in writing, of the Executive Directors of the Fund.

- incurred in the interest of the Fund previded that Dee shall certify in connection with each claim for reimbursement that he has not received and will not claim reimbursement in respect to such expenses from any other source. Such expenses shall include travel and transportation expenses for Dee and his immediate family and the cost of moving their personal effects once to the seat of the Fund during or immediately before his term of effice and in moving once from the seat during or immediately after his term of effice, and shall also include reasonable expenses for housing and for entertainment and for other similar expenditures made on behalf of the Fund.
- 9. Dee agrees, upon demand by the Executive Directors or such person or persons as they may designate, to supply such evidence as may be desired in connection with any claim for reimbursement under the terms of paragraph 8 of this agreement.
- 10. As used in paragraph 8 of this agreement the term "immediate family" shall mean Dee's wife, children, personal servants and such other persons who habitually reside with Dee.

11. In the event that at the expiration of any year during which this contract is in effect. Doe shall notify the Fund, in writing. that the salary paid to him fer such year and/or the sum due or paid to him as reimbursement for expenses are subject to taxation by the national government of the country of which he is a citizen, then the Fund shall pay to Dee an additional sum equal to the amount necessary te permit him to pay all such taxes and retain the full amount of all sums paid to him under paragraphs (7) and (8). In calculating the payments to be made under this paragraph. Dee shall be deemed to have received no income from any other source, except that when Dee is not employed by the Fund during the full calendar year, tax computations shall be made on the basis of his income received from the Fund plus any ether income received during that year for personal services at a rate net exceeding \$30,000 annually net of national inceme taxes, plus reasonable reimbursement for expenses. After such computations have been made the Fund shall pay to Doe that part of the tax which bears the same propertien to such total tax as the income he receives from the Fund bears to such total income.

12. Des agrees to furnish upon request to the Executive Directors or to such person or persons as they may designate, all pertinent evidence with respect to his tax payment and liabilities.

15. Any additional sums which shall be due to Doe pursuant to paragraph 11 above shall be paid by the Fund at such time or times as Doe is required to meet his tax liabilities. Such payments shall be made in the currency in which the tax has been paid or in which the tax liability exists. If Doe is required to make payments on the basis of an estimated return, paymen to made under paragraph 11 shall be adjusted when Doe's payments to the taxing authoritiem are adjusted.

13. As used with respect to the provisions concerning taxation above, the term "national government" shall include the government of any state, province, county, municipality or any other political subdivision of the country of which Doe is a citizen as well as the government of the country itself.

Ih. The salary paid to Dee shall be paid in United States dellars in twenty-four (24) equal installments on the 15th and last day of each menth during which this agreement is in force. Reimbursement of expenses pursuant to this agreement shall be made in the currency in which such expenses were incurred, unless Dee was required to purchase such currency with another, in which case reimbursement shall be made in the currency used by Dee. Such reimbursement shall be made within a reasonable time after such expenses have been incurred and have been certified to the Fund.

Any additional sum which shall become due to Dee pursuant to paragraph 11 above shall be paid by the Fund within 60 days of receipt of the netification in writing provided for by such paragraph. Such payments shall be made in the currency in which the tax has been paid or in which the tax liability exists.

16. In the event that Dee should become ill during the time that this agreement is in ferce and such illness, whether mental er physical, shall incapacitate Dee from the performance of his duties, he shall, nevertheless, be entitled to receive full salary during the period of such illness for a period not to exceed six menths in any calendar year or six successive menths. In the event that any such illness shall

exceed six menths during the course of any calendar year or shall exceed six successive menths, Dee shall be entitled to receive salary at one-half the rate stipulated in paragraph 7 during the continuance of such illness. Upon Dee's resumption of his duties full salary shall again be payable to him from the date of such resumption.

- 17. If this agreement shall be terminated by the Executive Directors for reason of the illness of Doe, pursuant to the terms of the following paragraph, such termination shall be deemed to be a termination without cause and Doe shall receive the additional compensation set forth in the following paragraph. Such termination shall from the date thereof supersede and render ineffective the previsions of the preceding paragraph.
- 18. In accordance with the previsions in paragraph 1(b) the Fund, acting through the Executive Directors, has the option to terminate this agreement without cause at any time, such cancellation to be effective as of any date fixed by the Fund. In the event that this option is exercised by the Fund, the Fund agrees to pay to Dee, in addition to the salary which he has earned up to the date of such termination, an amount to be determined as follows:
 - (a) If the effective date of such termination shall occur during the first three (3) years that this agreement is in effect, then the amount of such additional compensation shall be one-half of the amount due for the unexpired term of the agreement.

- (b) If the effective date of such termination shall occur during the fourth year that this agreement is in effect, then the amount of such additional compensation shall be an amount equal to one full year's salary.
- (c) If the effective date of such termination shall occur during the fifth year that this agreement is in effect, then the amount of such additional compensation shall be the amount due for the unexpired term of the agreement.

Amounts paid under this paragraph shall be subject to the previsions of paragraph 11.

- Managing Directer or that the Executive Directors shall terminate this agreement for cause, Doe or his estate shall receive salary in full up to the date of his death or to the effective date of such resignation or termination, plus salary for all unused vacation time, but no additional compensation. Doe or his estate shall also receive reimbursement for all expenses provided for by paragraph 8 incurred up to such date. Amounts paid under this paragraph shall be subject to the previsions of paragraph 11.
- 20. In the event that the Executive Directors shall terminate this agreement pursuant to the provisions of paragraph 1(b) hereof, such termination shall not be deemed to be for cause unless prior to such termination the Executive Directors shall have given ten days notice to Doe of their intention so to terminate the agreement and shall have given

Doe the appertunity to be heard by them. Furthermore, no termination shall be deemed to be for cause unless the Executive Directors specifically so state at the time that they terminate the agreement.

However, the Executive Directors shall be the sole judges of the completeness and adequacy of any hearing given to Doe and it is agreed that their decision as to whether a termination is for cause shall be conclusive.

- 21. It is agreed that Dee shall be entitled to a vacation of thirty-one (31) normal working days in each calendar year and to the extent that such permitted vacation or any pertion thereof is not taken in any calendar year it may be accumulated, but Dee may not accumulate more than sixty-two (62) days of vacation. If Dee spends a pertion of his vacation in the country of which he is a citizen, time spent in travelling to or from such country shall not be subtracted from the amount of vacation to which he is entitled, provided, however, that such travel time is allowable only once in any calendar year.
- 22. In the event that the Fund shall establish a retirement plan, an employee's group life insurance plan, or any other health or social welfare plan, and as long as Dee is an employee of the Fund, he shall be entitled to contribute to and to enjoy the benefits of such plans in accordance with the terms and conditions thereof as they may be in force from time to time.
- 23. In the event that either the Fund or Dec shall breach any condition, term or prevision of this agreement, no waiver of such breach shall be deemed to be a waiver of any preceding or subsequent breach of the same condition, term or prevision or of any other.

- 24. All notices under this agreement which may be required to be given by either party must be in writing. Notices to the Fund shall be by registered mail addressed to the Executive Directors of the Fund at its head effice. Notices to Dee shall be by registered mail addressed to him at the head office of the Fund or to such other address as Dee may subsequently designate in writing and file with the Executive Directors of the Fund. The day following the date of mailing any such notice shall be desmed to be the date of its delivery.
- 25. This agreement is a personal contract and rights and interests hereunder may not be seld, transferred, assigned, pledged or hypothecated.
- and the Fund concerning the construction, application or effect of any of the previsions of this agreement such disagreement shall be determined by arbitration. The Fund and Dec shall each appoint one arbitrator. If either the Fund or Dec shall fail to designate an arbitrator within ten (10) days after written request from the other, the party making such request shall be entitled to designate two (2) arbitrators. The two arbitrators who are chosen shall select a third. The arbitrators, by the decision of a majority of them, may determine the place or places for hearing and determining the controversy and may adopt their own rules of procedure. The written decision of a majority of said arbitrators shall be final and conclusive on the Fund and on Dec.
- 27. This agreement shall be interpreted in accordance with the laws of the District of Columbia.

28. This agreement constitutes the entire agreement between Dee and the Fund and cannot be medified except by a written instrument signed by the parties herete which may, however, amend, medify or cancel this agreement without the censent of any other person whomseever.

IN WITNESS WHEREOF, the parties hereto have duly executed this agreement written in several counterparts, any one of which may be considered an original without the production of the others.
