# K - REPURCHASES AND CHARGES

- Men a member repurchases its currency from the Fund with gold in accordance with its repurchase obligations, the Fund shall lavy no charge for the transaction provided the gold is delivered to any of the designated gold depositories of the Fund. The Fund may accept gold situated elsewhere and may lavy an appropriate charge equal to the cost of moving the gold to its nearest gold depository.
- K-2 At the end of each financial year of the Fund, the Fund shall request all members to provide the data necessary to calculate the repurchase obligations of the member. On the basis of these reports the Fund shall inform the member how such of its currency it is required to repurchase and the extent to shich payment is to be sade in gold and in each convertible currency.
- K-3 When a member repurchases its currency from the Fund with convertible currencies of members in accordance with its repurchase obligations, the Fund shall lovy no charge for the transaction.
- K-4 At quarterly intervals the Fund shall inform each member of the charges due to the Fund on balances of its currency held by the Fund in excess of its quota.
- Gold in payment of charges may be delivered at any gold depository of the Fund or elsewhere at the direction of the Fund. To avoid the shipment of small quantities of gold, the Fund may accept in payment of charges the currency of any member if that currency may be used to purchase gold freely from the member within the prescribed range of parity.
- E-6 A member entitled to pay part of its charges in its own currency shall inform the Fund of the smount of its monetary reserves at the time the charges are due and the Fund shall accept payment of the appropriate part of the charges in the member's currency.
