February 11 - April 5, 1985

Introduction

A course on Government Finance Statistics, conducted in Spanish, was presented by the IMF Institute in cooperation with the Bureau of Statistics over an eight-week period.

Selection of participants

The Admissions Committee considered 57 applications from 22 member countries before selecting the following 33 participants from: Argentina, Bolivia (2), Brazil (3), Chile (2), China (1), Colombia (2), Costa Rica (2), Dominican Republic (2), Ecuador (2), El Salvador, Guatemala, Honduras, Mexico (2), Nicaragua, Panama (2), Paraguay, Peru (2), Portugal, Spain, Uruguay and Venezuela (2). In addition, a staff member of the Bureau of Statistics attended the course as an observer (see Attachment I).

Subject matter of the course

The objective of the course was to train country officials in techniques for the compilation of government finance and related statistics in accordance with the concepts, definitions and procedures set forth in the Draft Manual on Government Finance Statistics.

Participants examined the analytical framework for the recording of government financial operations and were familiarized with a number of related issues including coverage, recording basis, timing and consolidation. During the course, participants examined the accounts from which required data are extracted, derived aggregate data from such accounts, and classified government transactions according to various criteria. Participants were introduced to methods used for adjusting data for compilation in accordance with the recommended principles, and classifying revenue, expenditure, financing, and debt in accordance with the Manual. In addition to central government, participants reviewed techniques for the compilation of data for state and local governments and for nonfinancial public enterprises. They studied the relationship between government finance statistics and other data systems, discussed the IMF area departments' needs of government statistics, and were introduced to fiscal analysis issues.

Organization of the Course

During the course a total of 61 sessions were held; of these 33 sessions were devoted to case studies and workshops (Attachment II). Sessions concerned with government finance statistics were conducted by staff members of the Bureau of Statistics. Specialized lectures, a case study on fiscal analysis and the area departments' needs of government finance statistics were presented by the Fiscal Affairs and the Western Hemisphere Departments. Lectures on the organization, activities and evolution of the Fund were presented by the IMF Institute.

The Fund's Draft Manual on Government Finance Statistics was the basic reference work for the case studies and workshops except for the one related to nonfinancial public enterprises for which a new format for assembling data on an accrual basis was discussed. For most sessions background reading material was distributed to the participants in advance. The summaries and case studies listed in Attachment III were supplemented by selected published material and Fund documents.

To carry out case studies and workshops activities, participants were divided into seven small working groups. In completing their tasks, participants made use of published accounts and data from several countries and also worked with hypothetical examples designed to illustrate specific government transactions. During the course each participant discussed the main problems in the compilation of data in his own country and future work in the government finance statistics project with a staff member of the Government Finance Division.

Social Activities

A reception was held at the Fund on Thursday, February 14 to welcome participants and to introduce them to management, members of the Executive Board, and the staff.

The participants were entertained at luncheons hosted by their Executive Directors, and by area departments responsible for their countries. In addition, the Institute organized a number of outings including a visit to New York and several social gatherings at the Concordia. The Institute also assisted participants in adjusting to life in the Washington area.

Certificates of attendance were presented to the participants by the Director of the IMF Institute at the farewell luncheon held on Friday, April 5.
