Report on the Arab Monetary Fund Seminar on Balance of Payments

March 9-26, 1985

Introduction

The Arab Monetary Fund (AMF) with the assistance of the Bureau of Statistics and the IMF Institute, conducted a balance of payments seminar in the United Arab Emirates over an eighteen day period. The Fund representatives were Messrs. Arie C. Bouter and Paul R. Cotterell (both of the Bureau of Statistics). The AMF handled the selection of the 17 participants who came from 15 of its member countries and the AMF staff. The countries represented were Iraq, Jordan, Kuwait, Libya, Mauritania, Morocco, Oman, Saudi Arabia, Somalia, Sudan, Syria, Tunisia, the United Arab Emirates (2), the Yemen Arab Republic, and the People's Democratic Republic of Yemen (Attachment I).

Organization of the seminar

The scope and subject matter of the seminar were similar to those presented in the IMF Institute courses on Balance of Payments Methodology, although the degree of detail provided in the content of the seminar was of necessity less, owing to the shorter period available. In addition to the opening and closing sessions, a total of twenty-five lectures and workshops were presented (Attachment II). Thirteen lectures on balance of payments methodology, based on the Fund's Balance of Payments Manual, and six sessions devoted to a review of country practices and the solution of practical exercises, were conducted by the Fund staff. Three lectures on the operation of the AMF and balance of payments policies were conducted by the staff of the AMF. Three lectures on national accounts methodology were conducted by Dr. Akel, Chief of the Statistics Division of the Economic Commission for Western Asia. The sessions by the Fund staff were delivered in English with simultaneous translation into Arabic.

The main study material for the lectures and workshops consisted of the fourth edition of the Balance of Payments Manual, the Balance of Payments Training Course Textbook, and workshop exercises prepared by the Balance of Payments Division of the Bureau of Statistics. This material was translated into Arabic by the Bureau of Language Services and was distributed to participants prior to the seminar.

The seminar was well organized, with excellent collaboration being received from the staff of the AMF. The seminar benefited from the wide range of experience of the participants, who expressed great interest in the subject matter of the seminar and engaged in lively discussions. It

is expected that, as a result of the seminar, the coverage of balance of payments data in AMF countries will increase, and that the quality of the data provided to the Fund will also improve. Also, the seminar will have prepared some of the less experienced participants for more effective participation in IMF Institute courses.

The Fund's contribution to the seminar was greatly appreciated by the AMF.

Certificates of attendance were presented to the participants by the President of the AMF, Mr. Ghobash, during the closing session on March 26.
