Subject: Forthcoming Annual Meetings of the Board of Governors -  
Results of Voting on Board of Governors' Resolution

In accordance with the recommendations approved by the Executive Board at Executive Board Meeting 84/120, August 3, 1984, the Secretary has canvassed the votes cast by Governors on the Resolution submitted to the Board of Governors on August 7, 1984, with respect to Forthcoming Annual Meetings of the Board of Governors.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of Governors (74), exercising two thirds (619,439) of the total voting power (929,158) are required for a quorum. Article XII, Section 5(c) provides that, except as otherwise specifically provided, all decisions of the Fund shall be made by a majority of the votes cast. These requirements have been met. A total of 854,474 votes was validly cast by 114 members in favor of the Resolution. The votes of each member are shown in the attachment. Accordingly, the Resolution is adopted by the Board of Governors, effective September 11, 1984. The Resolution will be designated No. 39-3.

The ballots and all correspondence relating to the voting are available in the Secretary's Department.

Unless an Executive Director requests that this matter be placed on the agenda, this report will be deemed approved as of the close of business today, Wednesday, September 12, 1984. The Executive Board's approval will be recorded in the minutes of the next meeting. Members will be informed of the results.
