1. MANAGING DIRECTOR - CONTRACT

At the request of an Executive Director, the Executive Board met, in executive session, to consider the question of the selection of a Managing Director for a period of five years on the expiration of the term of Mr. de Larosière at the end of the day of June 16, 1983.

The Executive Directors selected Mr. Kafka as Chairman of the meeting.

After discussion, the Executive Directors took the following decision:

The Executive Directors unanimously decide to ask Mr. de Larosière to continue as Managing Director for another five-year term after the end of his present term. The Executive Directors further decide to establish a committee composed of Mr. Erb, Mr. de Groote, Mr. Finaish, Mr. Laske, Mr. Zhang, and Mr. Kafka as Chairman, to negotiate with Mr. de Larosière the terms of his new contract.
