Subject: Salary of the Managing Director - Results of
Voting on Board of Governors Resolution

In accordance with the decision of the Executive Board adopted at Executive Board Meeting 83/68, May 12, 1983, the Secretary has canvassed the votes cast by Governors on the Resolution submitted to the Board of Governors on May 16, 1983, with respect to the salary of the Managing Director.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of Governors (74), exercising two thirds (431,399) of the total voting power (647,098) are required for a quorum. Article XII, Section 5(c) provides that, except as otherwise specifically provided, all decisions of the Fund shall be made by a majority of the votes cast. These requirements have been met. A total of 619,549 votes was validly cast by 129 members in favor of the Resolution. A total of 12,100 votes was validly cast by one member against the Resolution. The votes of each member are shown in the attachment. Accordingly, the Resolution is adopted by the Board of Governors effective June 13, 1983, and will be designated No. 38-2.

The ballots and all correspondence relating to the voting are available for inspection in the Secretary's Department.

Unless an Executive Director requests that this matter be placed on the agenda, this report will be deemed approved as of the close of business today, Tuesday, June 14, 1983. Members will be informed of the result and the Executive Board's approval will be recorded in the minutes of the next meeting thereafter.
