

The attached consolidated table provides information on the use of Concorde by Executive Directors and staff since the inauguration of such flights in 1976 through the most recent twelve-month period ending November 30, 1985.

The standard for use of the Concorde by the staff has remained unchanged. The standard requires that there must be savings of stopovers, in-and-out expenses, and/or working time equal in amount to the additional cost of travel by Concorde. If the saving is less than the additional cost, then the difference is paid by the staff member.
