Algeria -- Statistical Issues

1. Outstanding Statistical Issues

a. Prices and merchandise trade

Data on prices and external trade are uncurrent. Although report forms have been sent regularly by the Bureau of Statistics, no responses have been received for the past several years.

b. Government finance

No replies have been received to GFS questionnaires and there is no page for Algeria in the GFS Yearbook.

c. Monetary data

During the April-May 1985 Article IV Consultation mission, the staff has received provisional estimates for key monetary aggregates as at the end of 1984, including those relating to deposit banks where there had been considerable delays in the past. No quarterly breakdown was provided for 1984. There was a substantial revision of the item "net foreign assets of the banking system" because of a reclassification of documentary bills of credit. For the purposes of IFS, however, the Bureau of Statistics would need to review the detailed data on the components of the monetary aggregates prior to publication of the data.

2. Coverage, Currentness, and Reporting of Data in IFS

The table below shows the currentness and coverage of data published in the country page for Algeria in the June 1985 issue of IFS. The data are based mostly on reports sent to the Fund's Bureau of Statistics by the Central Bank of Algeria, which during the past year have been provided infrequently.
