Subject: Report on the 1992 Annual Meeting

The Board of Governors held its 1992 Annual Meeting in Washington, D.C., from September 22-24, 1992. The Annual Meeting was preceded by meetings of the Interim Committee and the Development Committee. 1/

The Interim Committee met on September 20-21, 1992 with Mr. Carlos Solchaga as Chairman. The press communiqué of the Interim Committee was circulated as Fund Press Release No. 92/72 (Attachment I). On September 22, 1992, the Board of Governors heard a report by Mr. Solchaga, which has been circulated as Joint Press Release No. 16. The Committee agreed to hold its next meeting in Washington, D.C., on April 30, 1993.

The Development Committee met on September 21, 1992, with Mr. Alejandro Foxley as Chairman, and issued a press communiqué (Attachment II). On September 22, 1992, the Board of Governors heard a report by Mr. Foxley on the work of the Committee during the period July 1991-June 1992, in compliance with Section 5(i) of the Fund Board of Governors Resolution No. 29-9, adopted October 2, 1974; this report has been circulated as a Joint Annual Meetings document (Fund Document No. 5) and has been issued as Joint Press Release No. 7. The Development Committee agreed to meet again in Washington, D.C., on May 1, 1993. The concluding remarks of the Chairman will be circulated to the Committee of the Whole for the Development Committee.

1/ Prior to the Annual Meeting, the Chairman of the Board of Governors, following the advice of the Joint Procedures Committee, decided that the credentials of the Government of President Jean-Bertrand Aristide of Haiti be accepted and that no delegations from Somalia and Yugoslavia be seated.

The Development Committee also had a meeting on September 24, 1992, at which it selected His Excellency Ricardo Hausmann, Minister of State and Head, CORDIPLAN, Venezuela, to serve as Chairman.
