1. DRAFT AGENDA

The Committee members considered a draft agenda for the twenty-fourth meeting of the Development Committee to be held on September 23, 1984 (EB/CW/DC/84/4, 8/3/84; Sup. 1, 8/8/84; and Sup. 2, 8/27/84).

The Executive Secretary of the Development Committee noted that the World Bank Committee of the Whole had discussed the Bank staff report "Toward Sustained Development: A Joint Program of Action for Sub-Saharan Africa (R84-224)" the previous week. Some members had voiced disappointment that the World Bank had not proposed a special action program for Africa, while others considered that it was the responsibility of the members of the Development Committee, on the basis of the analysis and proposals in the staff report, to suggest possible courses of action for the Fund and the World Bank.

The Bank Committee of the Whole had also discussed the "Draft President's Report to the Development Committee on Current Development Issues (R84-225)," which had since been modified in the light of some of the Committee members' suggestions to give greater emphasis to trade issues and the debt situation, the Executive Secretary went on. The provisional agenda had been approved without discussion.

All members of the Committee had been invited by the Chairman of the Development Committee to attend an informal dinner on September 22 to discuss the Committee's future work program, the Executive Secretary stated. The Chairman wished to discuss at that time possible modifications to procedures in order to improve the efficiency of the meeting and to give particular emphasis to the question of sub-Saharan Africa.

In his summary of the discussion in the Bank's Committee of the Whole, the President of the World Bank had urged the members of the Development Committee to focus their statements on the African issue, the Executive Secretary remarked. Given the situation in sub-Saharan Africa, he himself hoped that the Development Committee would be able to give some guidance to both the Bank and the Fund on the direction of their future involvement in that region. The implementation of any recommendations made by the Committee would be discussed at a later meeting.

Responding to a question from Mr. Jayawardena, the Executive Secretary of the Development Committee stated that the traditional procedure, whereby Ministers discussed all topics on the agenda, would be followed at the forthcoming Committee meeting, but particular attention should be given to the problems of sub-Saharan Africa. Perhaps Ministers could focus on the latter issue during the first round of interventions. It would also be helpful if Ministers could make their statement available before the meeting began, so that copies could be distributed to other members of the Committee, and inserted in the record. Ministers could then comment in more detail on the problems of sub-Saharan Africa.
