Dear Mr. Minister:

On behalf of the Executive Board and staff, I wish to welcome you into the International Monetary Fund as Governor for Kenya.

During a recent conversation with the Chairman of the Interim Committee, the Honorable Allan MacEachen, we considered the invitation that the then Minister of Finance, the Honorable Mwai Kibaki, kindly extended to the Interim Committee to hold its spring meeting in Nairobi next year. The letter of invitation has been circulated to Executive Directors for their information and no action has been taken on the matter by the Committee which can be expected to take up the place of the 1983 spring meeting at its Helsinki meeting this May.

In this connection I drew to Chairman MacEachen's attention that the meeting rooms now under construction as a part of the enlargement of the Fund building in Washington are scheduled to be completed next spring. As you may know, for many years the Interim Committee has been without meeting facilities in the Fund and these meeting rooms were constructed, in part, to fill that need.

Based on the views expressed within the Executive Board, the Chairman and I have concluded that the members of the Interim Committee generally can be expected to favor holding their spring 1983 meeting so as to inaugurate the new meeting rooms.

I would appreciate hearing from you about this matter. I wonder whether you would agree that it would be difficult to schedule a meeting elsewhere at the very time the meeting facilities at the Fund's headquarters will have been completed. With your understanding of the situation, we would plan on the basis that the Interim Committee will inaugurate the new facilities in Washington in the spring of 1983.
