Subject: **Membership for the Republic of Montenegro—Voting Results**

In accordance with the decision of the Executive Board recorded in the minutes of Executive Board Meeting EBM/06/99, November 17, 2006, the Secretary has canvassed the votes cast by Governors on the proposed Resolution submitted to the Board of Governors on November 17, 2006 with respect to the Membership for the Republic of Montenegro.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of the Governors (91), exercising two thirds (1,472,304) of the total voting power on December 15, 2006 (2,208,456), are required for a quorum. Article XII, Section 5(c) provides that, except as otherwise specifically provided, all decisions of the Fund shall be made by a majority of the votes cast. These requirements have been met. A total of 2,174,406 votes were validly cast by 158 members in favor of the proposed Resolution. Accordingly, the Resolution is adopted by the Board of Governors, effective December 15, 2006, and will be designated No. 61-8.

The votes of each member are shown in the attached table. The ballots and all correspondence relating to the voting are available for inspection in the Secretary's Department.

Unless an Executive Director requests that this matter be placed on the agenda, this report will be deemed approved by **the close of business on Wednesday, December 20, 2006**. The Executive Board's approval will be recorded in the minutes of the next meeting thereafter. Members will be informed of the results.
