7. QUOTA AND VOICE REFORM—GOVERNORS' VOTE

The Executive Board approves the report of the Secretary (SM/06/293, Sup. 2) on the canvass of votes of the Governors on Resolution No. 61-5, effective September 18, 2006, with respect to Quota and Voice Reform, approved by the Executive Board (EBM/06/78, 8/31/06) for submission to the Board of Governors.
