1. The Fund has received the attached request from the authorities of the Republic of Kosovo to continue to provide technical assistance in the macroeconomic, fiscal, monetary, financial, and related statistical fields, including training programs and assistance that strengthen the legal and administrative framework in these core areas and in relation to Kosovo's application for Fund membership). The request builds on previous Fund technical assistance that has been provided to Kosovo since 1999 at the request of the United Nations Mission in Kosovo (UNMIK).¹

2. On July 10, 2008, the Republic of Kosovo applied for membership in the Fund and its application was placed before the Executive Board on July 14, 2008.² On July 14, 2008, it was determined for Fund purposes that the Republic of Kosovo has seceded from the Republic of Serbia and is a new independent state. Accordingly, for Fund purposes, the Republic of Kosovo is a nonmember country. In prior cases, the Fund has approved requests for technical assistance in the context of a nonmember country's application for Fund membership. The case of Montenegro is a recent example.³

3. Under Rule N-16(d) of the Fund's Rules and Regulations, the advance approval of the Executive Board is necessary for the provision by Fund staff of technical assistance in response to a request by a nonmember country. Accordingly, a proposed decision is set forth below.

Proposed Decision

The following decision, which may adopted by a majority of the votes cast, is proposed for adoption by the Executive Board:

Following a request for technical assistance received from the Republic of Kosovo, the Executive Board approves the provision of technical assistance to the Republic of Kosovo in the macroeconomic, fiscal, monetary, financial, and related statistical fields, including training programs and assistance that strengthen the legal and administrative framework in these core areas and in relation to Kosovo's application for Fund membership.



Most recently, UNMIK has benefited from assistance on public financial management, tax administration, and the medium-term expenditure framework.
