Introduction

During the latter part of 1977, the Managing Director held informal consultations with Executive Directors in order to ascertain their views regarding the appropriate size of the overall increase of quotas and on the question of selective quota adjustments. In Buff Statement 77/77 (June 10, 1977) on the Seventh General Review of Quotas, the Managing Director noted: "In helping to identify the countries whose quotas might be regarded as most seriously out of line, I believe a set of new quota calculations based on recent data and using the same techniques and formulas that have been used in previous quota reviews would be helpful." This paper presents those quota calculations. The data used in making the calculations are for periods ending in 1976, and are the most recently available for the membership as a whole. As the same techniques and quota formulas have been used in making these updated quota calculations as used in previous quota reviews, the calculations presented below are directly comparable with those made for the Fifth General Review of Quotas (SM/69/58, May 8, 1969, and SM/69/88, June 16, 1969) and the Sixth General Review of Quotas (EB/CQuota/74/2, July 15, 1974).

Quota calculations bear essentially on the question of the measurement of the relative out-of-lineness of quotas. The Managing Director, in Buff Statement 77/77, mentioned above, noted that "a reasonable measure of out-of-lineness would be if a member's calculated quota, as determined by the new calculations, exceeded the Sixth Review agreed quota by a very substantial amount". However, while the individual quota calculations are a useful set of composite indicators of members' relative positions since the last quota review, they also provide some aggregate evidence of the overall growth of the world economy since then and have therefore a bearing on the possible need to increase the overall size of Fund quotas in connection with the current quota review. To some extent, therefore, the calculations presented below supplement the considerations dealing with the need to increase Fund quotas outlined in SM/77/62, March 21, 1977 (The Adequacy of International Liquidity). As shown below (Page 9), the calculated size of the Fund, has increased by 90.4 per cent in the four-year period 1973-1976.

It may be recalled that, as regards the quota formulas and the techniques adopted in applying the result of the formulas, the Executive Directors noted in their Report to the Interim Committee on the Seventh General Review of Quotas (SM/77/231, Rev. 2, September 12, 1977) that the view was advanced that "...the relative economic positions of members should be re-examined three years after the conclusion of the Seventh General Review so as to determine whether further selective quota adjustments would be justified. In this connection, a few Directors believe that, once the Seventh Review is completed, it would be appropriate to review the principles upon which quota increases have been based in the past, while others hold the view that attention should be paid in such a study, if made, to the consequences of fuller use of the customary quota formulas".

Section I of the paper deals with the data used in making the quota calculations and touches on some difficulties, conceptual and others, regarding the data used; Section II discusses the use of the quota formulas and the techniques used to determine a "calculated quota" for each member; the final section summarizes the main findings.

#### I. Data Used in Quota Calculations

Data have been collected for 132 <sup>1/</sup> countries that were members of the Fund on January 31, 1978 and also for Surinam, which is expected soon to be a member of the Fund.

##### Period covered by calculations

The following data for each country have been used in the quota calculations:

- (a) national income at current market prices for 1976;
- (b) official holdings of gold (valued at SDR 35 per ounce) and foreign exchange as of the end of 1976;
- (c) annual exports of goods, on a customs (f.o.b.) basis, for the 13 years 1964-76;
- (d) annual imports of goods, on a customs (c.i.f.) basis, for the five years 1972-76;
- (e) annual external current receipts (goods, services and private transfers) as recorded in the balance of payments for the 13 years 1964-76;
- (f) annual external current payments (goods, services and private transfers) as recorded in the balance of payments for the five years 1972-76.

### Sources of data

A considerable amount of estimation had to be utilized in compiling these data (see Appendix Table I and the accompanying notes as well as the country notes in Appendix II). It was particularly difficult to obtain national income data for 1976 and for members' external transactions on service account and for private transfers. In the estimation of services and private transfers, the same methods have been employed on this occasion as for the Sixth General Review so that continuity of the time series of the relevant data has been maintained. All other data used in making the calculations derive from either the Fund's International Financial Statistics or the Balance of Payments Yearbook or official national sources.

### Conversion to SDRs

All data are expressed in SDRs. National currency data of official holdings of gold and foreign exchange have been converted into U.S. dollars and from U.S. dollars into SDRs by use of end-of-year exchange rates; data for national income and the trade and current account variables have been converted by use of average annual exchange rates.

Conversion of domestic economic aggregates such as national income into a common international standard, such as the SDR, through the use of representative market exchange rates for the local currency may result in some distortions of members' positions because of the existence of dual exchange markets, multiple currency practices adopted by members and the existence of exchange controls. Furthermore, the speed and extent to which domestic price increases are reflected in the exchange rate can differ from country to country resulting in relative under or over valuations of exchange rates over the short-run. However, it may be presumed that the widespread floating of currencies since 1973 has reduced the size of currency overvaluations and undervaluations so that the distortion introduced by the use of market exchange rates is probably now less serious than in the past. A further difficulty arises in the case of data on national income aggregates, since these aggregates in each country include expenditures on items which are not exchanged internationally. However, as these problems are to a more or less degree common to most countries and after a careful examination of the national income data for individual countries, and the exchange rates used for making conversions of the data, it does not seem that any special adjustments of the national income data are called for with respect to the quota calculations or that some members' positions have been greatly affected in relative terms by the use of possibly nonrepresentative rates of exchange in converting these national income data.

Following current Fund practice, official gold holdings have been valued for each country at the official price of SDR 35 an ounce, even though some countries value their gold holdings in relation to market prices and the official price of gold at the end of 1976 was considerably

below its market price. While the valuation of official holdings of gold is a difficult issue, it is not one that has a major bearing on the quota calculations. Official reserves (including gold) are included in only one of the quota formulas--the Bretton Woods formula--and their weight in that formula is small.<sup>1/</sup> It is also noteworthy that gold is not now readily used as a reserve asset and, under the Amended Articles, members will not be required to pay gold as part of their subscriptions to the Fund.

Insofar as the figures for trade and payments are concerned, the data for Singapore, Bahrain, the Bahamas, the United Arab Emirates, and the People's Democratic Republic of Yemen have been adjusted downward, following the practices of previous quota reviews, in order to take into account their large entrepot trade which tends to inflate unduly both the import and export figures. Details of the adjustment are provided in Appendix II.

#### Individual variables in the quota calculations

The rates of growth of the variables used in making quota calculations for the Fifth, Sixth, and Seventh general quota reviews are shown in Table 1. It can be seen from the table that despite the reduction in the normal five-year period between general reviews to four years, the average rates of growth of the trade variables for the period between the Sixth and Seventh Reviews, i.e., for 1973-76 inclusive, are greater than average rates of growth of the variables for the two preceding general review periods which covered five years. On an annual basis, the compound rates of growth for all variables except reserves for the period 1973-76 are higher than for the preceding general review periods. This is a measure of the inflation of prices of internationally traded commodities that has occurred in recent years. The impact of inflation on the rate of growth of national income, expressed in terms of SDRs, was less severe.

A noteworthy feature of Table 1 is the striking acceleration in the rate of growth of the data for the variability of exports and the variability of current receipts. Variability is an important element in the quota formulas and, therefore, in the outcome of the quota calculations. Designed to measure fluctuations over a period of 13 years around a medium trend, the indicator of variability is calculated as one standard

deviation of the data from this trend, which is represented by the five-year moving average.<sup>1/</sup>

The relatively large increase in the variability figures reflects the considerable turbulence in the international economy in the few years prior to end 1976, and this finds some quantitative expression in the quota calculations. The figures of variability used in the calculations made for the Seventh Review are on average four times those used in connection with the Sixth Review, and for some members, especially the major oil exporting countries, the variability figures show an even larger rate of increase. The increase in variability was somewhat lower for the non-oil developing countries taken as a group.

## II. Quota Formulas and "Calculated Quotas"

The original quotas adopted in Bretton Woods in 1944 were based on a formula (the original Bretton Woods formula) which equated the calculated quota to the product of (i) the sum of 2 per cent of national income, 5 per cent of reserves, 10 per cent of imports and 10 per cent of export variability and (ii) 1 plus the ratio of exports to national income. In a revision of the method of quota calculations made at the time of the fourth General Quota Review (1963/64), the definition of variability was changed, though the weight of variability in the modified formula was broadly maintained, and all weights were uniformly reduced by one-half which brought the calculated Fund size more closely in line with the actual size of the Fund at that time. At the same time, 15 formulas were derived from the Bretton Woods formula through various modifications of the weights of the variables, the effect of the modifications being to eliminate the weight for reserves, reduce the weight of national income, and increase the weights of trade and variability of exports in the quota formulas.

Of the 15 formulas, 6 (Schemes I to VI) retained the multiplicative factor (1 plus the ratio of exports to national income) of the Bretton Woods formula while the other nine (Schemes M1 to M9) were linear and had no multiplicative factor. In addition to the calculations using trade figures (Set I data), a new set of calculations was introduced with current accounts figures (Set II data) in place of the trade figures. The details of the composition of each of these formulas are given in Appendix III below and the calculations using each of these quota formulas are presented in Appendices IV to VII.<sup>1/</sup>

The multiplicity of formulas indicates the difficulty of deriving a single quota formula that would produce reasonable quota calculations for members, taking into account the existing structure of quotas in the Fund and the desirability of proceeding slowly with shifts in that structure.<sup>2/</sup> However, applying all the calculations for each member would result not only in an unwieldy number of calculations, but also in too wide a range of results on which to base a reasonably coherent pattern of increases in quotas. After the introduction of the new quota formulas prior to the Fourth Review, calculations were made for the Review using all the new formulas. However, calculations using only five formulas were selected so as to narrow the range within which selective quota increases might be considered, and also to shift the quota structure somewhat in favor of the developing countries. As noted earlier, the preferred formulas were: the Bretton Woods formula (revised and reduced), two nonlinear formulas (Schemes III and IV) and two linear formulas (Schemes M4 and M7). While calculations have continued to be made in subsequent reviews using all the quota formulas, actual use of the calculations has been confined to the original selection of five formulas with regard to the determination of a single "calculated quota" for each member.<sup>3/</sup> In the staff's view there do not seem to be strong reasons to change this particular combination of quota formulas that has been used in previous reviews as the basis for determining a single "calculated quota" for each member.<sup>4/</sup>

### Quota Calculations

Quota calculations have been made using Set I and Set II data and all 16 quota formulas for all members as of January 31, 1978 (except China) and for Surinam which is expected to be a member soon. The calculations for Luxembourg have been included with those for Belgium, in view of the fact that certain data for Luxembourg are included with those of Belgium. These calculations are presented in Appendices IV to VII. Set I calculations are based on data for national income, official holdings of gold and foreign exchange, exports, imports and variability of exports; in the Set II calculations, current receipts, current payments and the variability of current receipts are substituted for exports, imports and variability of exports. For some countries, though a diminishing number, Set I calculations produce higher figures than Set II calculations mainly because the total of current receipts for a country is sometimes more stable than export receipts alone thereby lowering the quantitative significance of the variability element in the calculations for a particular member. Some countries also have small invisible external transactions or private transfers on external account which affects their relative positions in each calculation.

Since the quota formula revision of 1963/64 (when the Set II calculations were introduced), the Set I calculations have been maintained to provide continuity with previous reviews and also in view of the paucity of the data on current invisibles for a relatively large number of Fund members. In future reviews, it may be possible to use only Set II calculations.

In order to compare the various quota calculations made for each member and also to derive a single calculated quota from these calculations, each individual set of calculations has been "normalized" on the total size of the Fund that results from calculations made using Set I data and the Bretton Woods formula. This total is SDR 95.4 billion. The individual calculations could, however, be normalized on any given figure, and the results could be shown as a set of ratios. Normalizing the calculations on the total quotas resulting from the Bretton Woods formula has been used in previous reviews and this permits comparisons of the quota calculations to be made with calculations made for these earlier reviews. Furthermore, it was felt by the staff that Executive Directors would be interested in having available the absolute figures of the calculations rather than ratios or calculations that had been normalized on, for example, the size of Fund resulting from the Sixth General Review of Quotas--i.e., SDR 39 billion. For ease of comparison the summary of calculations made for previous quota reviews and those made in connection with this review are shown in Table 2.

As can be seen from this table, the calculated size of the Fund (excluding China) based on Set I data and using the Bretton Woods formula has grown at an accelerated rate for each review since calculations were made in connection with the Fourth Quinquennial Review of Quotas using data ending in 1962. After discounting the accession of new members, the calculated size of the Fund using 1976 data is five times as large as the size of the Fund using 1962 data;

it grew by 91.5 per cent in the four years 1973 to 1976. Because the total of actual quotas resulting from a general quota review has been smaller than the size of the Fund calculated in connection with that review, the ratio of actual quotas to calculated quotas has fallen over time; a declining ratio means that the growth of quotas has not been keeping up with the growth of the world economy.

#### Calculated Quotas

As mentioned above, five of the quota formulas have been selected for determining a single "calculated quota" for each member. The Bretton Woods formula continues to be the most appropriate formula for making the quota calculations of the industrial countries and, in particular for the United States, with relatively large national income and comparatively small international trading sectors. The remaining four formulas--Schemes III and IV, and M<sup>4</sup> and M<sup>7</sup>--which emphasize the importance of trade and the variability of trade, generally produce the higher results for the developing countries. The various steps in deriving a calculated quota for each member are as follows:

- (i) The calculations based on the Bretton Woods formula using Set I and Set II data are shown in Column A of Table 3;
- (ii) The lowest two calculations of formula Schemes III, IV, M<sup>4</sup> and M<sup>7</sup> using Set I data have been averaged and the lowest two calculations from these schemes using Set II data have been averaged and these are shown in Column B of Table 3;
- (iii) The higher of the averages of the calculations shown in Columns A and B of Table 3 is the "calculated quota", and these are shown in Column C of Table 3.1/

The derivation of a single calculated quota for each member provides a yardstick against which a member's actual quota may be compared, thereby giving some indication of a member's relative growth since the last quota review was completed and also an indication of its position in the total of calculated quotas as well as against other individual members' calculated quotas.

The overall sum of the calculated quotas is SDR 99.9 billion (compared with a calculated Fund of SDR 95.4 billion computed on the basis of the Eretton Woods formula using Set I data). The total of quotas agreed under the Sixth General Review is SDR 38.5 billion,<sup>1/</sup> so that the total of the excess of the calculated quotas over the Sixth Review agreed quotas is SDR 61.4 billion, or 159.4 per cent.

The greater part of the total excess of calculated over agreed quotas is concentrated among the main industrial countries and the major oil exporting countries. An indication of changes in the relative positions of members is the percentage difference between "agreed" (i.e., quotas proposed in connection with the Sixth General Review) and "calculated" quotas. Table 3, Col. E, shows the excess of the calculated Seventh Review quota over the proposed Sixth Review quota expressed as a percentage of the proposed Sixth Review quota. Table 4 shows in summary form the distribution of the excess of Seventh Review calculated quotas over proposed Sixth Review quotas while Table 5 <sup>2/</sup> shows the ranking of countries by the percentage size of the excess of the calculated over the agreed (i.e., Sixth Review) quota.

Table 4 shows that percentage excesses in the Seventh Review are larger than the percentage excesses in the Sixth Review. The large positive excesses between calculated and agreed quotas are indications that in relation to the growth of the world economy the overall and, in some cases, individual increases in quotas agreed in connection with the Sixth General Review of Quotas were relatively small.

### III. Summary and Conclusions

The calculations presented in this paper, based on recent data and using the same techniques and formulas as employed in the three previous quota reviews, show very large rates of growth of calculated quotas since the preceding quota review:

(i) The sum of the calculated quotas based on data ending in 1976 shows an increase of almost 91 per cent over the total of calculated quotas derived for the Sixth General Review on the basis of data ending in 1972. The annual compound rate of growth of the calculated quotas for the period 1973-76, inclusive, is almost 18 per cent compared with a growth rate of 11 per cent for the five years (1967-72) covered by the Sixth General Review.

The relatively high rate of growth of the calculated quotas is reflected in relatively large excesses of individual calculated quotas over agreed (Sixth Review) quotas; on average, the excesses are proportionately larger than the excesses of calculated Sixth Review quotas over the actual (Fifth Review) quotas.

(ii) The large excess in the calculated size of the Fund over both the agreed quotas and over the calculated size of the Fund made in connection with the Sixth General Review, could be regarded as an indication of the need for a relatively substantial overall increase in Fund quotas.

(iii) The excess of the calculated quota over the agreed quota expressed as a percentage of agreed quota is particularly large for a few countries. The very large excesses for the few countries may be regarded as an indication that these members' present quotas are seriously out of line both in relation to other quotas and in relation to the present overall size of the Fund and that some relative increase in these quotas would be warranted.

Notes on Data

Data used in calculating members' quotas are expressed in millions of SDRs. The source of data, unless otherwise specified, is the IMF Data Fund, or official national authorities.

1. National income

National income data used are in current market prices and were converted into SDR equivalents from national currency figures by first converting into U.S. dollars by the annual average exchange rate for 1976 and then applying the average SDR/U.S. dollar conversion ratio for 1976 SDR 0.86616 = US\$1. For a number of countries, national income data were not available and were estimated. In cases of countries for which national income data were available for a recent year and data on GDP or GNP were available for 1976, the ratio of national income to GDP or GNP for the latest available year was applied to GDP or GNP for 1976 to derive national income for that year. For countries which had no national income figures for any recent year but had GDP or GNP data for 1976 (these countries are less developed countries), the average ratio of national income to GDP (0.925) or GNP (0.934) of 35 less developed countries were applied to GDP or GNP to estimate national income unless otherwise indicated in the country notes.

2. Reserves

Reserves data used are gold and foreign exchange holdings as at the end of December 1976.

3. Exports and imports

Exports and imports statistics were drawn mainly from the Data Fund and correspond to the international transactions data (customs basis) published in the IFS. For countries with substantial entrepot trade (Bahrain, Bahamas, Singapore, United Arab Emirates, and People's Democratic Republic of Yemen), trade as well as balance of payments data were adjusted for re-exports.

4. Current receipts and payments

Data on invisibles and private transfers (gross credits and gross debits) were not available for a number of countries and were estimated. Unless otherwise indicated in the country notes, estimates were made by applying the regional averages of current receipts to exports and current payments to imports, respectively, to the exports and imports of members for which appropriate balance of payments data were not available. The ratios used were of eight oil exporting countries (Algeria, Indonesia, Iran, Iraq, Libya, Nigeria, Saudi Arabia and Venezuela) for other oil-exporting countries; of eight Asian countries

(Burma, India, Korea, Malaysia, Philippines, Singapore, Sri Lanka, Thailand) for other Asian countries; and of nine African countries (Ethiopia, Ghana, Ivory Coast, Kenya, Mauritius, Morocco, Sudan, Tanzania, Zambia) for other African countries. The ratios employed are as follows:

2. Individual quota calculations based on various formula schemes presented in Appendices IV - VII have been adjusted so that they sum to a total Fund of SDR 95.4 billion. This is the sum of calculated quotas based on the revised Bretton Woods formula reduced by 50 per cent (as shown below), using Set I data, i.e., exports and imports in the formula components. Each quota formula used in the calculation of quotas was given a separate adjustment factor which is the ratio of the sum of quotas calculated by each formula scheme (including the revised Bretton Woods formula reduced using Set II data) to the sum of quotas calculated by the revised Bretton Woods formula in its reduced form (using Set I data) —i.e., which yields SDR 95.4 billion. All individual quota calculations were multiplied by the adjustment factor appropriate to the formula scheme. This required using 31 different adjustment factors as quotas have been calculated by use of 31 different formula schemes in addition to the revised Bretton Woods formula in its reduced form using Set I data.
