authorities were anxious to see the extended Fund facility program brought to a successful conclusion as a way of encouraging the Executive Board to agree to extended arrangements for other African countries facing similar problems.

The Chairman said that, like some Directors, he was worried by the increase in recurrent expenditures in Malawi. Table 3 of EBS/84/32, Supplement 1 showed that expenditure for wages and salaries was expected to increase 30 percent, from MK 68 million in 1982/83 to MK 89.5 million in the revised projections for the 1984/85 budget. Since wages and salaries had been frozen over the period, the increase must have been due largely to a growth in the number of people employed in the Administration. With a GDP growth rate of only 3 percent a year, a 30 percent increase in expenditure for wages and salaries was troubling, and he hoped that future missions to Malawi would see to it that such expenditures were more strictly monitored and contained.

The Executive Board then took the following decision:

1. Malawi has consulted with the Fund in accordance with paragraph 4(b) of the extended arrangement with Malawi and paragraph 34 of the memorandum attached to the letter from the Minister of Finance and the Governor of the Reserve Bank of Malawi dated July 29, 1983, attached to the extended arrangement for Malawi (EBS/83/183, Supplement 1) in order to review progress under the program and to reach understandings subject to which further purchases may be made by Malawi under the extended arrangement.
2. The letter from the Minister of Finance and the Governor of the Reserve Bank of Malawi dated February 27, 1984 shall be annexed to the extended arrangement for Malawi, and the letter of July 29, 1983 attached to the extended arrangement shall be read as supplemented by the letter of February 27, 1984. Accordingly, the understandings referred to in paragraph 4(b) of the extended arrangement for Malawi relating to domestic assets of the banking system, net bank credit to the Government, and external borrowing shall be those specified in paragraphs 7 and 8 of the letter of February 27, 1984.
3. With respect to the additional matters referred to in paragraph 34 of the letter dated July 29, 1983, the Fund finds that no further understandings are necessary.
4. The extended arrangement for Malawi shall be amended as follows:
 - (a) Paragraph 2(a) shall be amended to read:

"Until June 1, 1984, purchases under the extended arrangement shall not, without the consent of the Fund, exceed the equivalent of SDR 20 million, provided that purchases shall not exceed the

equivalent of SDR 5 million until October 31, 1983; the equivalent of SDR 10 million until January 31, 1984; and the equivalent of SDR 15 million until April 30, 1984."

(b) In paragraph 4(a), replace "April 30, 1984" with "June 1, 1984."

(c) In paragraph 4(c), replace "April 29, 1984" with "May 31, 1984."

3. ANNUAL REPORT, 1984 - OUTLINE AND PROCEDURES

The Executive Directors, without comment, adopted the following decision:

The Executive Board approves the draft outline and proposed procedures for the 1984 Annual Report set forth in EBD/84/71 (3/8/84).

4. WORK PROGRAM

Mr. Coene recalled that Mr. de Groote had circulated for the information of Executive Directors a statement explaining the Belgian proposal for conditional SDR allocations. That statement was not intended to be discussed as a specific proposal at the March 26 meeting on SDR allocations, which should focus on the effort to assess whether or not the conditions for an SDR allocation of the traditional type had been met. Mr. de Groote's proposal should rather be considered as food for thought or discussion at some future meeting, after the April 12 meeting of the Interim Committee.

The Executive Board took note of Mr. Coene's remarks.
