Subject: Derestriction of GATT Documents

The Fund has received the attached letter (Attachment 1) from the Executive Secretary of the CONTRACTING PARTIES requesting the Fund's views as to the derestriction by the end of September of certain GATT documents including the following:

L/79 - Results of Fund's 1952 Article XIV consultations with the United Kingdom in respect of Southern Rhodesia and with Sweden and Finland, as set forth in the Fund's letters of February 11 and 24, 1953 to the Chairman of the CONTRACTING PARTIES. The document also reproduces the results of the Fund's 1952 consultation with the United Kingdom which were sent to the CONTRACTING PARTIES on October 2, 1952.

L/75 - Note submitted by the Belgian Delegation to the GATT Intersessional Committee on February 4, 1953 which describes the action taken by Belgium to relax restrictions on dollar imports and in which reference is made to the Belgian Delegate's statement at the Seventh Session regarding the intentions of his Government to relax these restrictions in its desire "to meet the wishes of the CONTRACTING PARTIES and of the International Monetary Fund".

None of the other documents being considered for derestriction contains any reference to the Fund or to material submitted by the Fund.

The staff recommends that the Fund request continued restriction of Document L/79 and express no objection to the derestriction of L/75 and the other documents listed for derestriction. A draft letter appearing as Attachment 2 is submitted for approval.
