Subject: **Report of the Standing Joint Committee on the Remuneration of Executive Directors and their Alternates—Changes in Retirement Benefits for Executive Directors and their Alternates—Voting Results**

In accordance with the decision of the Executive Board recorded in the minutes of Executive Board Meeting 10/64, June 28, 2010, the Secretary has canvassed the votes cast by Governors on the proposed Resolution submitted to the Board of Governors on June 28, 2010, with respect to the changes in retirement benefits for Executive Directors and their Alternates.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of the Governors (94), exercising two thirds (1,480,723) of the total voting power on July 30, 2010 (2,221,085), are required for a quorum. Article XII, Section 5(c) provides that, except as otherwise specifically provided, all decisions of the Fund shall be made by a majority of the votes cast. These requirements have been met. A total of 1,417,221 votes was validly cast by **132** members in favor of the proposed Resolution. A total of 412,626 votes was validly cast by three members against the Resolution. Accordingly, the Resolution is adopted by the Board of Governors, effective July 30, 2010, and will be designated No. 65-3.

The votes of each member are shown in the attached table. The ballots and all correspondence relating to the voting are available for inspection in the Secretary's Department.

Unless an Executive Director requests that this matter be placed on the agenda, this report will be deemed approved by **noon on Thursday, August 5, 2010**. The Executive Board's approval will be recorded in the minutes of the next meeting thereafter. Members will be informed of the results.
