Subject: **Report of the Committee on Rules for the 2010 Regular Election of Executive Directors—Voting Results**

In accordance with Executive Board Decision No. A/13297, which was recorded in the minutes of Executive Board Meeting 10/73, the Secretary has canvassed the votes cast by Governors on the proposed Resolution submitted to the Board of Governors on July 15, 2010, with respect to the 2010 Regular Election of Executive Directors.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of the Governors (92), exercising two thirds (1,480,723) of the total voting power on August 5, 2010 (2,221,085), are required for a quorum. Pursuant to Article XII, Section 3(b), an 85 percent majority (1,887,922) of the total voting power must be in favor of the Resolution for its adoption. The required voting majority has not been met. A total of 1,682,957 votes, representing 75.77 percent of total voting power, was validly cast by 157 members in favor of the proposed Resolution. Accordingly, the Resolution has not been adopted by the Board of Governors.

The votes of each member are shown in the attached table. The ballots and all correspondence relating to the voting are available for inspection in the Secretary's Department.

Unless an Executive Director requests that this matter be placed on the agenda, this report will be deemed approved by **noon on Monday, August 9, 2010**. The Executive Board's approval will be recorded in the minutes of the next meeting thereafter. Members will be informed of the results after the Executive Board has approved the voting results.
