Subject: **Regulations for the Conduct of the 2010 Regular Election of Executive Directors—Voting Results**

In accordance with the decision of the Executive Board recorded in the minutes of Executive Board Meeting 10/104, October 29, 2010, the Secretary has canvassed the votes cast by Governors on the proposed Resolution submitted to the Board of Governors on October 27, 2010 with respect to the 2010 Regular Election of Executive Directors.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of the Governors (93), exercising two thirds (1,480,723) of the total voting power on November 3, 2010 (2,221,085), are required for a quorum. Pursuant to Article XII, Section 3(b), an 85 percent majority (1,887,922) of the total voting power must be in favor of the Resolution for its adoption. These requirements have been met. A total of **2,210,610** votes was validly cast by **178** members in favor of the proposed Resolution. Accordingly, the Resolution is adopted by the Board of Governors, effective November 3, 2010, and will be designated No. 66-1.

The votes of each member are shown in the attached table. The ballots and all correspondence relating to the voting are available for inspection in the Secretary's Department.

Unless an Executive Director requests that this matter be placed on the agenda, this report will be deemed approved by **3:00 p.m. on Wednesday, November 3, 2010**. The Executive Board's approval will be recorded in the minutes of the next meeting thereafter. Members will be informed of the results.
