Subject: **Managing Director—Proposed Acceptance of the Atlantic Council’s 2011 Global Citizenship Award**

The Ethics Committee has received a request from the Managing Director to approve her proposal to accept the Atlantic Council’s 2011 “Global Citizenship Award” on September 21, 2011. Under the terms of the Managing Director's contract, her acceptance of awards is subject to the approval of the Executive Board, which shall only be given in circumstances where acceptance of the award would not give rise to an actual or perceived conflict of interest. Under the framework for the Application of the Standard of Ethical Conduct vis-à-vis the Managing Director, the Ethics Committee is responsible for making recommendations to the Executive Board in this regard.

The Atlantic Council is described as a “non-partisan, non-governmental organization that has as its mission the renewal of the Atlantic Community for global challenges, ranging from financial instability to violent extremism ... [and] has promoted constructive U.S and European leadership and engagement in international affairs”. The Atlantic Council states that the Global Citizenship Award is made in recognition of individuals who exceptionally represent its mission, honoring “the highest service to the global community”, and involves no monetary compensation. In addition to the proposal to make the award to the Managing Director, the Atlantic Council has indicated that the 2011 award will also be received by Senator John Kerry (U.S. Senate), and posthumously by former Lebanese Prime Minister Rafik Hariri.

The Ethics Committee, having consulted with the Fund’s Ethic’s Adviser, considers that the Managing Director’s acceptance of the Atlantic Council’s 2011 Global Citizenship Award would not give rise to an actual or perceived conflict of interest. Accordingly, the Ethics Committee recommends that the Executive Board approve the Managing Director’s request to accept the Global Citizenship Award.
