Subject: Organizational Changes and Changes Affecting Staff
Notified Under Rule N-12

In the context of the FY 1994 administrative budget, a number of organizational changes are being introduced. Three area departments (the Central Asia, European II, and Western Hemisphere Departments) are each being allocated one additional division, a number of division titles in these departments are being redesignated and a number of countries reassigned. The new division designations and country assignments, which will be effective May 1, 1993, are as follows:
