Subject: Membership for the Republic of Azerbaijan -
Results of Voting on Board of Governors Resolution

In accordance with the decision of the Executive Board adopted at Executive Board Meeting 92/59, April 20, 1992, the Secretary has canvassed the votes cast by Governors on the resolution submitted to the Board of Governors on April 20, 1992, with respect to membership for the Republic of Azerbaijan.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of the Governors (79), exercising two thirds (634,310) of the total voting power (951,465), are required for a quorum. Article XII, Section 5(c) provides that, except as otherwise specifically provided, all decisions of the Fund shall be made by a majority of the votes cast. These requirements have been met. A total of 919,743 votes were validly cast by 137 members in favor of the resolution. Accordingly, the resolution is adopted by the Board of Governors, effective May 4, 1992.

The votes of each member are shown in the attached table. The ballots and all correspondence relating to the voting are available for inspection in the Secretary's Department.

Unless an Executive Director requests that this matter be placed on the agenda, this report will be deemed approved as of noon, Tuesday, May 5, 1992. The Executive Board's approval will be recorded in the minutes of the next meeting. Members will be informed of the results.
