Subject: Governors' Per Diem Allowance at Meetings of
the Board of Governors

It has been the practice of the Fund and Bank in recent years to review the adequacy of the per diem allowances for Governors and Alternate Governors in connection with attendance at Annual Meetings on about a three-year to five-year basis. The last review was undertaken in 1988. As a result, the allowances were then increased from \$185 to \$240 for each night that attendance at the Meetings requires Governors and Alternates to spend away from their normal place of residence, and from \$33 to \$43 per night for overnight flights or when hotel accommodation is included in the price of transportation.

As indicated in Attachments I and II, costs have risen significantly between 1988 and 1992. The current average daily subsistence costs likely to be incurred by Governors and Alternate Governors in Washington, D.C. have risen 18.9 percent since 1988 and hotel costs by 27.6 percent (see Attachment I). The costs for meals are shown in Attachment II. Taking these cost factors into account, it is recommended that the per diem allowance be increased by 25 percent to \$300 and \$54, respectively. The standard in-and-out allowance would be increased from \$44 to \$65. The incremental costs to the Fund are estimated to be \$135,000, for which provision would be made in the FY1993 Board of Governors budget, if necessary. Governors and Alternate Governors would also receive their actual transportation expenses to and from the place of meeting. (Changes in Governors' allowances since 1946 are shown in Attachment III.)

Similar proposals are being submitted to the Executive Directors of the Bank.

The following draft decision is proposed for approval by the Executive Board:

The Executive Board approves the recommendation contained in EBAP/92/125 regarding per diem allowance for Governors and Alternate Governors during attendance at meetings of the Board of Governors.

In the absence of an objection by an Executive Director by the close of business on Tuesday, July 28, 1992, the proposed decision will be deemed approved by the Executive Board and it will be so recorded in the minutes of the next meeting thereafter.
