Mr. Santos considered that it would be entirely appropriate to send a letter to the authorities, which could be addressed to the President of Equatorial Guinea.

Ms. Hansen said that she agreed with the Chairman's proposal.

The Executive Board then took the following decision:

1. The Fund takes this decision in concluding the 1990 Article XIV consultation with Equatorial Guinea, in the light of the 1990 Article IV consultation with Equatorial Guinea conducted under Decision No. 5392-(77/63), adopted April 29, 1977, as amended (Surveillance over Exchange Rate Policies).

2. Except for the limits on the availability of foreign exchange for travel, which are maintained under the transitional arrangements under Article XIV, Equatorial Guinea maintains an exchange system that is free of restrictions on the making of payments and transfers for current international transactions. The Fund encourages Equatorial Guinea to adopt policies that would permit the early elimination of this restriction.

DECISIONS TAKEN SINCE PREVIOUS BOARD MEETING

The following decisions were adopted by the Executive Board without meeting in the period between EBM/91/40 (3/20/91) and EBM/91/41 (3/22/91).

4. TONGA - REPRESENTATIVE RATE FOR TONGAN PA'ANGA

The Fund finds, after consultation with the authorities of Tonga, that the representative exchange rate for the Tongan pa'anga under Rule 0-2(b)(i) against the U.S. dollar is the midpoint between buying and selling rates for the U.S. dollar as determined by the National Reserve Bank of Tonga. (EBD/91/76, 3/15/91).

5. ZAMBIA - TERMINATION OF SUSPENSION OF RIGHT TO USE SDRs

The Fund decides that the suspension of the right of Zambia to use SDRs, as provided in Executive Board Decision No. 8670-(87/116) S/TR, adopted August 3, 1987, is terminated with effect on March 7, 1991.
