Subject: Proposed Third Amendment of the Articles of Agreement -  
Voting Results on Board of Governors' Resolution

In accordance with the decision of the Executive Board adopted at Executive Board Meeting 90/83, May 30, 1990, the Secretary has canvassed the votes cast by Governors on the Resolution submitted to the Board of Governors on May 31, 1990, with respect to the proposed Third Amendment of the Articles of Agreement.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of the Governors (76), exercising two thirds (626,050) of the total voting power (939,075), are required for a quorum. Article XII, Section 5(c) provides that, except as otherwise specifically provided, all decisions of the Fund shall be made by a majority of the votes cast. These requirements have been met. A total of 745,428 votes were validly cast by 92 members in favor of the Resolution, and a total of 34,561 votes were validly cast by 12 members against the Resolution. Accordingly, the Resolution is adopted by the Board of Governors, effective June 28, 1990, and will be designated No. 45-3.

The votes of each member are shown in the attached table. The ballots and all correspondence relating to the voting are available for inspection in the Secretary's Department.

Unless an Executive Director requests that this matter be placed on the agenda, this report will be deemed approved as of the close of business today, Friday, June 29, 1990. The Executive Board's approval will be recorded in the minutes of the next meeting. Members will be informed of the results. A press release on this matter will be issued on Monday, July 2, 1990.
