1. AS FISCAL AGENCY FOR THE GOVERNMENT OF CHILE WE DESIRE TO PURCHASE FROM THE INTERNATIONAL MONETARY FUND SDR 18,750,000 IN ACCORDANCE WITH TERMS OF ARTICLE V, SECTIONS 3 AND 4.
2. WE DO HEREBY REPRESENT THAT THIS PURCHASE IS NEEDED IN ACCORDANCE WITH THE PROVISIONS OF FUND AGREEMENT.
3. PLEASE CREDIT CHILE'S SDR ACCOUNT WITH SDR 18,750,000 ON VALUE DATE OF PURCHASE.
4. THE EQUIVALENT OF DESIRED PURCHASE, NAMELY CHILEAN PESOS 6,205,321,684 WILL BE CREDITED TO FUND'S NR. 1 ACCOUNT WITH OURSELVES ON THE VALUE DATE OF PURCHASE.
5. REGARDING SERVICE CHARGE, PLEASE DEBIT CHILE'S SDR ACCOUNT WITH SDR 93,750 ON VALUE DATE OF PURCHASE.
6. PLEASE ARRANGE TO CREDIT OUR ACCOUNT WITH FEDERAL RESERVE BANK OF NEW YORK, NEW YORK WITH U.S. DOLLARS EQUIVALENT SDR 18,656,250 ON VALUE DATE OF PURCHASE.
7. WE STATE THAT ANY USE OF SDRS AT THIS TIME UNDER ARTICLE XIX, SECTION 2(A) IS IN ACCORDANCE WITH SECTION 3(A) OF THIS ARTICLE.
8. HOWEVER, WE AUTHORIZE YOU TO ARRANGE ON OUR BEHALF FOR ALL OR PART OF THIS AMOUNT TO BE SOLD TO PARTICIPANTS OR PRESCRIBED HOLDERS IN A TRANSACTION BY AGREEMENT.
