1. DEPUTY MANAGING DIRECTOR - EXTENSION OF APPOINTMENT

The Executive Directors, meeting in executive session, considered a memorandum from the Managing Director relating to the extension of the appointment of Mr. Richard D. Erb, as Deputy Managing Director, effective June 1, 1989 through May 31, 1994 (EBAP/89/138, 5/26/89).
