Report on Techniques of Economic Analysis Course in French

(1988-VI)

April 11 - June 3, 1988

Introduction

The course on Techniques of Economic Analysis in French (1988-VI) was conducted over an eight-week period.

Selection of participants

The Admissions Committee considered 103 applications from 39 member countries. The group that came to Washington consisted of 29 participants coming from the following countries: Algeria (2), Belgium, Benin, Burkina Faso (2), Burundi, Cameroon, Chad, China, Comoros, Congo, Côte d'Ivoire, Djibouti, France (2), Gabon, Guinea, Guinea-Bissau, Haiti, Madagascar, Mali, Mauritania, Morocco, Mozambique, Rwanda, Togo, Viet Nam, and Zaïre (see Attachment I).

Organization and content of the course

During the course, 96 sessions were held. These included 45 plenary sessions devoted to lectures, case studies, workshops, and discussions, 24 counseling sessions, 18 working group sessions, 6 free attendance sessions, 2 introductory sessions, and one closing session. Of the total number, 74 sessions were conducted by staff members of the Institute; 2 sessions were conducted by staff members of the Research Department; and 2 lectures were given by staff of the IBRD.

The course was divided into three parts. The first part reviewed the main concepts relating to macroeconomic aggregates and basic analytical methods used for evaluating a country's economic performance. It, therefore, dealt with statistical series and tools of statistical measurement such as index numbers, ratios, propensities, elasticities, and regression techniques.

The second part was devoted to analyzing the macroeconomic accounts of a country, Morocco, which was used as the main case study of the course. The objective was to help participants fully understand fundamental economic relationships in order for them to analyze a country's economic developments in the same manner as the Fund.

The third part dealt with the role, organization, procedures, policies, and activities of the Fund, as well as with several aspects of the international monetary system.

The course put emphasis on practical exercises, which were carried out in small groups with counseling provided by a staff member of the Institute's French Division. Most of these exercises were designed to illustrate the application of the analytical techniques referred to in the lectures. At the end of the course, each group of participants was asked to analyze the recent economic developments of the case study country and to identify this country's principal economic problems. The groups' reports were presented and discussed in plenary sessions.

The topics presented during the lectures and the summaries and documents distributed to participants are listed in Attachments II and III.

Social activities

A reception was given at the Fund on April 18, 1988, to welcome the participants and to introduce them to management, members of the Executive Board, and the staff.

The participants were entertained at luncheons hosted by their Executive Directors and by senior staff of area departments responsible for their countries. In addition, the Institute organized a number of weekend outings, excursions, and social gatherings at the Concordia.

Certificates of attendance were presented to the participants at a farewell luncheon held on June 3, 1988.
