Subject: Executive Board Travel

The Secretary has received the following memoranda:

1. From Mr. Rye, dated August 3, 1988:

Would you please inform the Executive Board that my Alternate, Mr. Lim, intends to travel on official Fund business to Port Vila to participate in the 1988 Article IV Consultation with the Vanuatu authorities and thereafter to Manila for discussion with our Philippine authorities.

Mr. Lim plans to leave Washington on September 6 and will return on or about September 19.

2. From Mr. Massé, dated August 4, 1988:

Would you please inform the Executive Board that my Advisor, Mr. Walter Engert, will be traveling to Berlin on official Fund business to attend the Annual Meetings.

Mr. Engert proposes to leave Washington on September 22, 1988 and to return on or about September 30, 1988.

3. From Mr. Nimatallah, dated August 4, 1988:

Please inform the Executive Board that I plan to travel to Saudi Arabia on official Fund business to consult with my authorities, and then to Damascus, Syria, to attend the Regular Meeting of the Council of Governors of Arab Central Banks and Monetary Authorities.

I plan to leave Washington on August 16, and to return on September 1, 1988.

4. From Mr. Ayales, dated August 5, 1988:

On behalf of Mr. Ortiz, kindly advise the Executive Board that I will travel to Mexico, on official Fund business, to lecture on the role of the Fund in the international monetary system at the Latin American Center for Monetary Studies (CEMLA) in Mexico City, during August 8-12.

I am planning to leave on August 7 and will return on or about August 13.

5. From Mr. Mawakani, dated August 5, 1988:

Would you please inform the Executive Board that my advisor, Mr. Jean-Christian Obame, will be traveling on official Fund business to Gabon to consult with the authorities.

Mr. Obame intends to leave Washington on August 12 and return on or about August 26, 1988.
