Introduction

The Arab Monetary Fund (AMF) with the assistance of the Bureau of Statistics conducted a money and banking statistics course in the United Arab Emirates for a three-week period. This course was the first of its kind in money and banking statistics conducted by the AMF. The Fund's representatives were Messrs. Michael J. Brimble and Peter J. Winglee (both of the Bureau of Statistics). The AMF handled the selection of the 25 participants who came from 15 of its member countries and the AMF staff. The countries represented were Bahrain, Jordan, Libya, Mauritania, Morocco, Oman, Qatar, Saudi Arabia, Somalia, Sudan, Syria, Tunisia, the United Arab Emirates, the Yemen Arab Republic, and the People's Democratic Republic of Yemen; there was also a participant from the staff of the UN Economic Commission for Western Asia (UNECA).

Organization of the course

The scope and subject matter of the course were similar to those presented in the first IMF Institute Course on Money and Banking Statistics in 1986, although the degree of detail provided in the content of the course was necessarily less, in view of the shorter period. In addition to the opening and closing sessions, the course comprised ten lectures, two case studies, and four workshops. An inaugural address was given by the President of the AMF, Mr. S. A. Ghobal. The first lecture covered the functions and operations of the AMF and was presented by an AMF staff member. The main lectures were based on the draft Guide to Money and Banking Statistics in International Financial Statistics (IFS), and the case studies and workshops were prepared by the staff of the Bureau's Financial Institutions Division. In addition, participants from seven countries 2/ gave presentations on various aspects of the methodology

underlying the money and banking data compiled and published in their countries. The bulk of the material used in the course, including the draft Guide, was translated into Arabic by the Bureau of Language Services, although some material was translated by AMF staff during the Course. Simultaneous translation of the lectures into Arabic was provided by a team of two interpreters.

The course was well organized, and excellent collaboration was received from the staff of the AMF. The course benefited from the wide range of experience of some of the participants, in particular the 16 participants who came from central banks. The participants expressed great interest in the subject matter of the course and engaged in lively discussions. It is hoped that, as a result of the seminar, the general quality of money and banking data in AMF countries will be improved, in particular, those provided to the Fund.

The Fund's contribution to the seminar was greatly appreciated by the AMF. Certificates of attendance were presented to the participants by the Acting President of the AMF, Mr. R. O. Khalid, during the closing session on March 26, 1987.

The program of the course, and a list of participants, are given in Attachments I and II, respectively.
