Dear Mr Ogada,

Pursuant to IMF Executive Board Decision No. 144–(52/51), we would like to inform you of the following restrictions on payments and transfers for current international transactions that are imposed solely to safeguard national and international security, territorial integrity, defense, and martial law as of 1 February 2023:
