Subject: **2023 Annual Meeting—Formal Notice and Brief Agenda**

Section 4 of the By-Laws provides, in part, that the Managing Director shall cause notice of the time and place of each meeting of the Board of Governors to be given to each member of the Fund by rapid means of communication not less than 42 days prior to the date set forth for such meeting. Section 6(a) of the By-Laws provides that the agenda for each meeting of the Board of Governors shall be prepared by the Managing Director, under the direction of the Executive Board, and that such agenda shall be transmitted with the notice of the meeting. Sections 6(b) and 6(c) of the By-Laws contain provisions for adding items to the agenda.

In accordance with these sections of the By-Laws, there is attached for consideration by the Executive Board a draft formal notice and brief agenda of the 2023 Annual Meeting that I propose be dispatched to all members by rapid means of communication.
