### EXECUTIVE SUMMARY

This supplement includes the proposed decisions to implement the proposals discussed in EBS/20/46. For the convenience of Executive Directors, Annex I include redlined text that shows the proposed amendments to the CCR Trust Instrument against the current provisions of the Trust Instrument.

## Proposed Decisions

The following decisions, which may be adopted by a majority of the votes cast, are proposed for adoption by the Executive Board:

### ***DECISION 1—Amendments to the Catastrophe Containment and Relief Trust***

Section III, Paragraphs 3(c)(iv) and 4(b)(ii) of the Instrument to Establish the Catastrophe Containment and Relief Trust annexed to Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020 shall be amended to read as set forth below:

#### **Paragraph 3. Catastrophe Containment Window (CC Window)**

##### **“(c) Amount and Delivery of Assistance**

(iv) Upon approval of a member’s request for grant assistance under the CC window, the Trustee shall disburse to a subaccount established for the benefit of the member pursuant to paragraph 4(b) below, a Trust grant in the amount that is necessary to repay the member’s eligible debt to the Fund falling due within the period specified in (i) above. For the purposes of this paragraph, eligible debt shall be defined as all of the member’s debt to the Fund (including to the Fund as Trustee) that was outstanding as of the date of the determination by the Fund that the member is qualified to receive grant assistance under this window and related charges and interest falling due over the period specified in (i) above, and in respect of which the member had made regular scheduled debt service payments (principal, charges and interest) before such determination. Eligible debt shall exclude any debt to the Fund that is scheduled to be repaid with assistance under other debt relief trusts administered by the Fund or under paragraph 2 of this Section.”

#### **Paragraph 4. Disbursements**

“(b) (ii) The Trustee shall use the proceeds disbursed for CC Window grant assistance under paragraph 3(c) promptly after such disbursement to effect the early repayment of an equivalent amount of the member’s eligible debt, with the repayments being attributed to the obligations in the order in which they fall due. However, the proceeds of Trust grants covering charges and interest specified in paragraph 3(c)(iv) above under the CC window shall be paid into the subaccount upon their due date and promptly used to repay the obligation due. If the amounts disbursed by the

Trustee to the subaccount exceed the amounts needed to effect early repayment of the member's eligible debt pursuant to the terms of the CC Window, then the Trustee shall be authorized to retransfer to the Trust an amount equivalent to such excess. Such retransfers will be made to the specific CCR Trust account from which the resources were drawn."

### ***DECISION 2—Determination of Qualifying Public Health Disaster***

The Fund, as Trustee of the Catastrophe Containment and Relief Trust, determines that, effective April 14, 2020, COVID-19 pandemic is a Qualifying Public Health Disaster under Section III, Paragraph 3(a)(ii)(II) of the Instrument to Establish the Catastrophe Containment and Relief Trust annexed to Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020.

### ***DECISION 3—Islamic Republic of Afghanistan—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1. The Islamic Republic of Afghanistan has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide the Islamic Republic of Afghanistan with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.
2. Pursuant to the terms of the CCR Trust, the Trustee determines that the Islamic Republic of Afghanistan is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.
3. Accordingly, the Trustee
  - a. decides to make available to the Islamic Republic of Afghanistan the amount specified for it in Table 2 of EBS/20/46 from the CCR Trust in the form of a grant to enable the Trustee, on behalf of the Islamic Republic of Afghanistan, to repay the Islamic Republic of Afghanistan's eligible debt (as defined in Paragraph 3 (c)(iv) of the CCR Trust Instrument) to the Fund (including to the Fund as Trustee), falling due in the period from April 14, 2020 to October 13, 2020;
  - b. will make available to the Islamic Republic of Afghanistan grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period

after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.

4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of the Islamic Republic of Afghanistan to effect the repayment of the Islamic Republic of Afghanistan's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

#### ***DECISION 4—Benin—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1. Benin has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide Benin with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.
2. Pursuant to the terms of the CCR Trust, the Trustee determines that Benin is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.
3. Accordingly, the Trustee
  - a. decides to make available to Benin the amount specified for it in Table 2 of EBS/20/46 from the CCR Trust in the form of a grant to enable the Trustee, on behalf of Benin, to repay Benin's eligible debt (as defined in Paragraph 3 (c)(iv) of the CCR Trust Instrument) to the Fund (including to the Fund as Trustee), falling due in the period from April 14, 2020 to October 13, 2020;
  - b. will make available to Benin grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of Benin to effect the repayment of Benin's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

#### ***DECISION 5—Burkina Faso—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1. Burkina Faso has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No.

14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide Burkina Faso with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.

2. Pursuant to the terms of the CCR Trust, the Trustee determines that Burkina Faso is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.
3. Accordingly, the Trustee
  - a. decides to make available to Burkina Faso the amount specified for it in Table 2 of EBS/20/46 from the CCR Trust in the form of a grant to enable the Trustee, on behalf of Burkina Faso, to repay Burkina Faso's eligible debt (as defined in Paragraph 3 (c)(iv) of the CCR Trust Instrument) to the Fund (including to the Fund as Trustee), falling due in the period from April 14, 2020 to October 13, 2020;
  - b. will make available to Burkina Faso grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of Burkina Faso to effect the repayment of Burkina Faso's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

***DECISION 6—Central African Republic—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1. The Central African Republic has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide the Central African Republic with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.
2. Pursuant to the terms of the CCR Trust, the Trustee determines that the Central African Republic is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.

3. Accordingly, the Trustee
  - a. decides to make available to the Central African Republic the amount specified for it in Table 2 of EBS/20/46 from the CCR Trust in the form of a grant to enable the Trustee, on behalf of the Central African Republic, to repay the Central African Republic's eligible debt (as defined in Paragraph 3 (c)(iv) of the CCR Trust Instrument) to the Fund (including to the Fund as Trustee), falling due in the period from April 14, 2020 to October 13, 2020;
  - b. will make available to the Central African Republic grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of the Central African Republic to effect the repayment of the Central African Republic's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

***DECISION 7—Chad—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1. Chad has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide Chad with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.
2. Pursuant to the terms of the CCR Trust, the Trustee determines that Chad is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.
3. Accordingly, the Trustee will make available to Chad grants pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3 above into a subaccount for the benefit of Chad to effect the repayment of Chad's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

***DECISION 8—Union of the Comoros—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1. The Union of the Comoros has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide the Union of the Comoros with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.
2. Pursuant to the terms of the CCR Trust, the Trustee determines that the Union of the Comoros is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.
3. Accordingly, the Trustee
  - a. decides to make available to the Union of the Comoros the amount specified for it in Table 2 of EBS/20/46 from the CCR Trust in the form of a grant to enable the Trustee, on behalf of the Union of the Comoros, to repay the Union of the Comoros' eligible debt (as defined in Paragraph 3 (c)(iv) of the CCR Trust Instrument) to the Fund (including to the Fund as Trustee), falling due in the period from April 14, 2020 to October 13, 2020 and an additional amount for the repayment of related interest and charges as specified in paragraph 3(c) (iv) of the CCR Trust Instrument, as applicable, which shall be determined at the time when such interest or charges are due;
  - b. will make available to the Union of the Comoros grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of the Union of the Comoros to effect the repayment of the Union of the Comoros' eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

***DECISION 9—Democratic Republic of the Congo—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1. The Democratic Republic of the Congo has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"),

established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide the Democratic Republic of the Congo with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.

2. Pursuant to the terms of the CCR Trust, the Trustee determines that the Democratic Republic of the Congo is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.
3. Accordingly, the Trustee
  - a. decides to make available to the Democratic Republic of the Congo the amount specified for it in Table 2 of EBS/20/46 from the CCR Trust in the form of a grant to enable the Trustee, on behalf of the Democratic Republic of the Congo, to repay the Democratic Republic of the Congo 's eligible debt (as defined in Paragraph 3 (c)(iv) of the CCR Trust Instrument) to the Fund (including to the Fund as Trustee), falling due in the period from April 14, 2020 to October 13, 2020;
  - b. will make available to the Democratic Republic of the Congo grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of the Democratic Republic of the Congo to effect the repayment of the Democratic Republic of the Congo's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

### ***DECISION 10—The Gambia—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1. The Gambia has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide The Gambia with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.
2. Pursuant to the terms of the CCR Trust, the Trustee determines that The Gambia is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.

3. Accordingly, the Trustee
  - a. decides to make available to The Gambia the amount specified for it in Table 2 of EBS/20/46 from the CCR Trust in the form of a grant to enable the Trustee, on behalf of The Gambia, to repay The Gambia's eligible debt (as defined in Paragraph 3 (c)(iv) of the CCR Trust Instrument) to the Fund (including to the Fund as Trustee), falling due in the period from April 14, 2020 to October 13, 2020;
  - b. will make available to The Gambia grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of The Gambia to effect the repayment of The Gambia's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

***DECISION 11—Guinea—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1. Guinea has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide Guinea with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.
2. Pursuant to the terms of the CCR Trust, the Trustee determines that Guinea is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.

4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of Guinea to effect the repayment of Guinea's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

**DECISION 12—Guinea-Bissau—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust**

1. Guinea-Bissau has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide Guinea-Bissau with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.
2. Pursuant to the terms of the CCR Trust, the Trustee determines that Guinea-Bissau is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.
3. Accordingly, the Trustee
  - a. decides to make available to Guinea-Bissau the amount specified for it in Table 2 of EBS/20/46 from the CCR Trust in the form of a grant to enable the Trustee, on behalf of Guinea-Bissau, to repay Guinea-Bissau's eligible debt (as defined in Paragraph 3 (c)(iv) of the CCR Trust Instrument) to the Fund (including to the Fund as Trustee), falling due in the period from April 14, 2020 to October 13, 2020;
  - b. will make available to Guinea-Bissau grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of Guinea-Bissau to effect the repayment of Guinea-Bissau's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

**DECISION 13—Haiti—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust**

1. Haiti has requested that the Fund, as Trustee (the "Trustee") of the Catastrophe Containment and Relief Trust (the "CCR Trust" or "Trust"), established by Decision No. 14649-(10/64), as amended by Decision No. 16684-(20/32), adopted March 26, 2020, provide Haiti with grant assistance for immediate debt relief under the Catastrophe Containment Window ("CC Window") of the CCR Trust.

2. Pursuant to the terms of the CCR Trust, the Trustee determines that Haiti is eligible and qualifies for grant assistance for immediate debt relief under the CC Window in accordance with Section III, Paragraphs 1 and 3(a)(i) and 3(a)(ii)(II) of the CCR Trust Instrument.
3. Accordingly, the Trustee
  - a. decides to make available to Haiti the amount specified for it in Table 2 of EBS/20/46 from the CCR Trust in the form of a grant to enable the Trustee, on behalf of Haiti, to repay Haiti's eligible debt (as defined in Paragraph 3 (c)(iv) of the CCR Trust Instrument) to the Fund (including to the Fund as Trustee), falling due in the period from April 14, 2020 to October 13, 2020.
  - b. will make available to Haiti grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of Haiti to effect the repayment of Haiti's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

***DECISION 14—Liberia—Request for Debt Relief Under the Catastrophe Containment Window of the Catastrophe Containment and Relief Trust***

1.   - b. will make available to the Republic of Yemen grants in additional tranches pursuant to Section III, paragraph 3(c)(i) to cover eligible debt falling due in the period after October 13, 2020 up to a maximum of two years from April 14, 2020, subject to the availability of resources in the Trust and to the provisions of the CCR Trust Instrument.
4. The Trustee shall disburse the amount specified in paragraph 3(a) above into a subaccount for the benefit of the Republic of Yemen to effect the repayment of the Republic of Yemen's eligible debt to the Fund in accordance with Section III, paragraph 4(b)(ii) of the CCR Trust Instrument.

## Annex I. Proposed Amendments (Redlined Text)

### Paragraph 3. Catastrophe Containment Window (CC Window)

#### (c) Amount and Delivery of Assistance

(iv) Upon approval of a member's request for grant assistance under the CC window, the Trustee shall disburse to a subaccount established for the benefit of the member pursuant to paragraph 4(b) below, a Trust grant in the amount that is necessary to repay the member's eligible debt to the Fund falling due within the period specified in (i) above. For the purposes of this paragraph, eligible debt shall be defined as all of the member's debt to the Fund (including to the Fund as Trustee) that was outstanding as of the date of the determination by the Fund that the member is qualified to receive grant assistance under this window **and related charges and interest falling due over the period specified in (i) above**, and in respect of which the member had made regular scheduled debt service payments (principal and interest) before such determination. **Eligible debt but** shall exclude any debt to the Fund that is scheduled to be repaid with assistance under other debt relief trusts administered by the Fund or under paragraph 2 of this Section.

### Paragraph 4. Disbursements

(b) (ii) The Trustee shall use the proceeds disbursed for CC Window grant assistance under paragraph 3(c) promptly after such disbursement to effect the early repayment of an equivalent amount of the member's eligible debt, with the repayments being attributed to the obligations in the order in which they fall due. **However, the proceeds of Trust grants covering charges and interest specified in paragraph 3(c)(iv) above under the CC window shall be paid into the subaccount upon their due date and promptly used to repay the obligation due.** If the amounts disbursed by the Trustee to the subaccount exceed the amounts needed to effect early repayment of the member's eligible debt pursuant to the terms of the CC Window, then the Trustee shall be authorized to retransfer to the Trust an amount equivalent to such excess. Such retransfers will be made to the specific CCR Trust account from which the resources were drawn.
