Additional Information:

In accordance with the decision of the Executive Board recorded in the minutes of Executive Board Meeting 20/71, June 19, 2020, the Secretary has canvassed the votes cast by Governors on the proposed Resolution submitted to the Board of Governors on June 16, 2020, with respect to the Amendment to Article XI of the Statute of the IMF Administrative Tribunal for the Conduct of Sessions Outside of Fund Headquarters.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of the Governors (95), exercising two thirds (3,356,208) of the total voting power on July 14, 2020 (5,034,311), are required for a quorum. This requirement has been met.

A total of **4,895,250** votes was validly cast by **156** members in favor of the proposed Resolution. No votes were cast against the Resolution. Article XII, Section 5(c) provides that, except as otherwise specifically provided, all decisions of the Fund shall be made by a majority of the votes cast.

Accordingly, the Resolution is adopted by the Board of Governors, effective July 14, 2020, and will be designated No. 75-2. Members will be informed of the results.

The votes of each member are shown in the attached table. The ballots and all correspondence relating to the voting are available for inspection in the Secretary's Department.
