Additional Information:

In accordance with the decision of the Executive Board recorded in the minutes of Executive Board Meeting 20/72, June 24, 2020, the Secretary has canvassed the votes cast by Governors on the proposed Resolution submitted to the Board of Governors on June 22, 2020, with respect to the Regulations for the Conduct of the 2020 Regular Election of Executive Directors.

The voting has been completed. Under Section 13 of the By-Laws, the replies of a majority of the Governors (95), exercising two thirds (3,356,208) of the total voting power on July 17, 2020 (5,034,311), are required for a quorum. Pursuant to Article XII, Section 3(c), an 85 percent majority (4,279,165) of the total voting power must be in favor of the Resolution for its adoption.

These requirements have been met. A total of **4,947,791** votes were validly cast by **172** members in favor of the proposed Resolution. No votes were cast against the Resolution. Accordingly, the Resolution is adopted by the Board of Governors, effective July 17, 2020, and will be designated No. 75-3. Members will be informed of the results.

The votes of each member are shown in the attached table. The ballots and all correspondence relating to the voting are available for inspection in the Secretary's Department.
